## Disclosure of a transparency notification

On 20 August 2019, SIPEF received a notification under the Law of 2 May 2007 on the disclosure of major shareholdings, with regard to the threshold crossing of 45% of the voting rights of SIPEF by Ackermans & van Haaren NV ("AvH") together with Cabra NV. As a reminder, AvH and Cabra NV exercise joint control over SIPEF by means of a shareholders agreement. The change in the shareholder structure is the result of purchases of SIPEF shares on the stock exchange by AvH on 14 August 2019. Following this transaction, AvH together with Cabra NV holds 45.98% of the voting rights of SIPEF, of which respectively 32.33% and 12.30% directly owned by AvH and Cabra NV and 1.35% own shares which SIPEF has in portfolio.

## 1. Chain of control above Ackermans & van Haaren NV

- I. Ackermans & van Haaren NV is directly controlled by Scaldis Invest NV, a company incorporated under Belgian law.
- II. Scaldis Invest NV is directly controlled by Belfimas NV, a company incorporated under Belgian law
- III. Belfimas NV is directly controlled by Celfloor SA, a company incorporated under Luxembourg
- IV. Celfloor SA is directly controlled by Apodia International Holding BV, a company incorporated under Dutch law.
- V. Apodia International Holding BV is directly controlled by Palamount SA, a company governed by Luxembourg law.
- VI. Palamount SA is directly controlled by Stichting administratiekantoor "Het Torentje", incorporated under Dutch law.
- VII. Stichting Administratiekantoor "Het Torentje" is the ultimate controlling shareholder.

In accordance with article 11, §1 of the Law of 2 May 2007, Stichting administratiekantoor "Het Torentje" is acting under its own name and at the expense of the companies mentioned under (II) until (VI).

## 2. Chain of control above Cabra NV

Priscilla Bracht, Theodora Bracht and Victoria Bracht jointly exercise control over Cabra NV.

## 3. <u>Chain of control above SIPEF (SIPEF own shares)</u>

Ackermans & van Haaren NV and Cabra NV jointly exercise control over SIPEF.
